

Conversion of Personal Property
To Real Property Instruction Sheet
For Lincoln County

- Step 1: Complete owner information.
- Step 2: Have Assessor's Office complete document. (Verify person is owner of land and or manufactured house, personal property taxes are paid in full.)
- Step 3: Sign in front of notary, have notary sign document.
- Step 4: Record at Recorder's Office (fee is approximately \$15.00)
(NOTE: Do not stamp or write anything in the 1" margins of the form or it may be rejected and/or incur additional recording fees)
- Step 5: Once you receive the recorded original Affidavit of Conversion send it to Manufactured Housing along with the original title for the mobile/ manufactured home and a check for \$40.00 (call to verify price).

NOTE: The conversion process **IS NOT** complete until the Assessor's Office receives a real property notice from Manufactured Housing. At that time the manufactured house will be placed on the succeeding years' tax roll as real property. In order to reverse the status of the house, proper forms must be completed. Forms for this process should be obtained from your local Assessor's Office. **The home cannot be moved unless an affidavit from real to personal property is recorded and submitted to the Assessor's Office.**

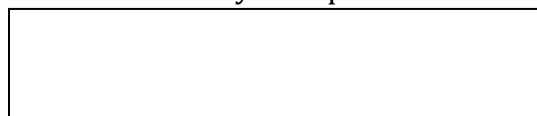
