SUMMARY - LINCOLN COUNTY ORDINANCE NO. \_\_\_\_\_ ORGANIZES THE LINCOLN COUNTY FIRE PROTECTION DISTRICT; DESCRIBES THE BOUNDARIES THEREOF; AUTHORIZES CONTRACTS BETWEEN COUNTY AND DISTRICT AND PROVIDES MATTERS APPROPRIATELY RELATED THERETO.

TITLE - LINCOLN COUNTY ORDINANCE NO. \_\_\_\_\_, AN ORDINANCE ENTITLED "LINCOLN COUNTY FIRE PROTECTION DISTRICT", ORGANIZES THE LINCOLN COUNTY FIRE PROTECTION DISTRICT AS A PERPETUAL POLITICAL SUBDIVISION OF THE STATE TO PROVIDE FOR THE PREVENTION AND EXTINGUISHMENT OF FIRES IN THE COUNTY PURSUANT TO NRS 474.460 TO 474.540, INCLUSIVE; DESCRIBING THE BOUNDARIES THEREOF AND THE TERRITORY INCLUDED THEREIN; AUTHORIZING CONTRACTS BETWEEN THE DISTRICT AND LINCOLN COUNTY; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO.

WHEREAS, pursuant to the authority of NRS 474.460 to 474.540, Lincoln County may adopt an ordinance or ordinances organizing as many fire protection districts as necessary to provide for the prevention and extinguishment of fires within Lincoln County; and

WHEREAS, The County has territory within its boundaries not included in any other fire protection district and it is necessary for promoting the health, safety, and general welfare of the citizens of Lincoln County to provide for the prevention and extinguishment of fires within all areas of Lincoln County.

NOW, THEREFORE, the Lincoln County Board of Commissioners does hereby ordain as follows:

**SECTION 1 . ORGANIZATION, NAME OF FIRE PROTECTION DISTRICT.**

Pursuant to the authority of NRS 474.460 to 474.540, Lincoln County hereby organizes the Lincoln County fire protection district to provide for the prevention and extinguishment of fires within Lincoln County; Section 2 of this ordinance describes its boundaries.

**SECTION 2. BOUNDARIES OF DISTRICT.**

Except as otherwise provided in this ordinance, the boundaries of the Lincoln County Fire Protection District shall be as follows:

See maps and descriptions attached hereto.

**SECTION 3. TERRITORY EXCEPTED FROM DISTRICT BOUNDARIES.**

The following territory is excepted from the territory described in Section 2 of this ordinance:

1. The incorporated areas of the city of Caliente.
2. Fire protection districts formed and existing in accordance with the provisions of : chapter 473 of NRS or NRS 474.010 to 474.450, inclusive, or other fire protection districts formed and existing in accordance with the provisions of NRS 474.460, inclusive.

**SECTION 4. CONTRACTS BETWEEN COUNTY AND DISTRICT.**

Pursuant to the provisions of NRS 474.475, the Board of County commissioners of Lincoln County, Nevada, hereby authorizes the execution of contracts between Lincoln County and the Lincoln County Fire Protection District for the prevention and control of fires and concerning the exercise of the powers provided in NRS 474.470.

**SECTION 5. EFFECTIVE DATE.**

This ordinance shall be in full force and effect from and after its passage, approval, and publication as prescribed by NRS 244.100.

**SECTION 6. CONFLICTS.**

All ordinances or parts of ordinances in conflict herewith are hereby repealed, but only to the extent of such conflict.

**SECTION 7. SEVERABILITY.**

If any section, paragraph, clause, or provision of this Ordinance shall for any reason be held to be invalid, unenforceable, or unconstitutional by any court of competent jurisdiction, the invalidity, unenforceability of such section, paragraph, clause, or provision shall not affect any remaining provisions of this Ordinance.

UPON ADOPTION, the County Clerk of Lincoln County is hereby directed to have this Ordinance published, by title only, together with an adequate summary including any amendments, once in a newspaper published in the County, if any, otherwise in a newspaper published in the County and having a general circulation in the County. The County Clerk is directed to post this Ordinance in full at the Lincoln County Courthouse. This Ordinance becomes effective twenty (20) days after its publication.
